PRESENTED BY THE EXECUTIVE DIRECTOR OF DELIVERY

1. Purpose

The purpose of this paper is to request approval from the Board of Directors with regard to the allocations of Birmingham & the Black Country Comprehensive Local Research Network (CLRN) funding and authorise payments in line with these allocations.

2. **Background**

- 2.1 The Trust is host to Birmingham & the Black Country CLRN under an Agreement with the Department of Health which expires on 31st March 2013. As host, the Trust has responsibility for managing the CLRN's funding.
- 2.2 The CLRN has a budget of £11,346,233 for 2011/12. This is divided into hosting costs, management costs and delivery funding.
 - 2.2.1 Hosting the CLRN is a cost-neutral activity. The host costs have been set by UHBFT finance department in line with NIHR guidance.
 - 2.2.2 Management costs constitute the pay and non pay costs associated with employing the CLRN management team, including an honorarium to the CLRN Board Chair and sessional payments to members of the CLRN Executive Group. These allocations have been made in line with NIHR guidance.
 - 2.2.3 Delivery funding is used to support the Research Management and Governance (RM&G) and NHS service support costs associated with delivering NIHR Portfolio studies. The RM&G element is costed using an activity based model. The service support element is primarily allocated through an application process based on the Member Organisations' and Local Research Networks' own stated needs.
- 2.3 The allocations to each organisation are presented in Appendix I. These have been approved by the CLRN's Executive Group and were ratified by the CLRN Board on 9 May 2011. Formal sign-off by the NIHR Clinical Research Network Coordinating Centre is expected by the end of May 2011.
- 2.4 The Board of Directors is asked to approve the allocation of the CLRN budget.

3. **Summary**

This paper outlines the aspects of CLRN funding for which the Trust is responsible and requests expenditure of the CLRN's budget in line with allocations approved by the NIHR.

4. Recommendations:

The Board of Directors is asked to:

APPROVE the allocation of CLRN funding as detailed in appendix 1.
